EBDM Phase V Kickoff Workshop: Wisconsin

June 29-30, 2015

Workshop Goals

In June 2008, the National Institute of Corrections (NIC) launched the Evidence-Based Decision Making (EBDM) in Local Criminal Justice Systems initiative. The EBDM Initiative aims to build a systemwide framework (from arrest through final disposition and discharge) that would achieve measurable reductions in pretrial misconduct and post-conviction offending. It conceptualizes a criminal justice system guided by goals defined and shared by policymakers; decisions informed by research evidence; a system guided by collaborative policy development; and a commitment to ongoing data collection and analysis to determine whether the goals of the system are effectively achieved. While first developed for local-level implementation, the Initiative has since been expanded and adapted to state-level decision making, and is now known as the *Evidence-Based Decision Making in State and Local Criminal Justice Systems* initiative.

In 2013, NIC shifted its focus to replicating the EBDM Framework on a statewide basis (Phase IV) in order to demonstrate the value of its expansion beyond single, local jurisdictions. Project staff worked closely with planning teams in five states to consider whether and how to expand their EBDM efforts beyond the original local teams to include additional local jurisdictions and state-level executives.

In February 2015, NIC announced its partnership with three states – Indiana, Virginia and Wisconsin – to replicate and expand EBDM to multiple local jurisdictions and state-level policy teams (Phase V). The goal of Phase V is to support the alignment of local and state systems of justice that are vision-driven, collaborative, and guided by evidence-based decision making. This EBDM Kickoff Workshop offers an opportunity to bring together the teams from Wisconsin to formally launch the statewide Initiative.

The goals of the meeting are to:

- Support the development of a shared vision for an effective system of justice throughout the State of Wisconsin
- Discuss the characteristics of highly effective teams and create opportunities to enhance collaboration
- Build methods for cross-team, cross-state and discipline-specific partnership and collaboration
- Begin the work of the Phase V Roadmap, including the identification of each team's vision and values, and beginning system mapping, and
- Create an action plan the team can carry forward upon returning home.

8:15 a.m. Plenary: What Does the Research Tell Us About Risk Reduction?

Governments around the world are moving to align their programs and services with evidence-based policy and practice (EBP). Started in the medical profession two decades ago, EBP asserts that public policy and practice must be based on the best available scientific evidence in order to be effective in the achievement of its goals and to be efficient in the use of taxpayers' dollars. This presentation will review key research findings related to the reduction of risk among justice-involved individuals and the implications of these findings for policy and practice.

9:15 a.m. Plenary: Introduction to System Mapping

One of the most fundamental ways to develop an understanding of a jurisdiction's justice system is to develop a "system map." Similar to an architectural diagram, a system map depicts the steps in the justice process (i.e., processing of a case and the activities related to this), beginning with law enforcement contact and ending with the point in time when the case terminates. In addition to reflecting the key decision points in the system, the map reflects the decision makers at each key point and the amount of time it takes a case to move from one point to the next. It is also possible and desirable to document the volume of cases that flow through each process step and decision point. There are many benefits to system mapping, including ensuring that key policymakers have a complete understanding of the entire system and its operations—not just its individual components—and facilitating discussion about the strengths of the system and opportunities to improve its efficiency and effectiveness.
