## Wisconsin State EBDM Policy Team Charter

**Policy Team Purpose/Vision:** The policy team was formed for the purpose of providing oversight and direction in the implementation of the Evidence Based Decision Making Initiative, and other statewide justice initiatives. It strives to achieve the following vision:

The criminal justice system reduces harm, promotes fairness and contributes to the quality of life in Wisconsin

#### **Forward**

**Policy Team Mission:** The policy team's mission is to build capacity to make evidence-based decisions at the individual, agency, and system levels, and to develop plans for implementing system-wide change strategies that will align state and local jurisdictions with one another and with the principles of EBDM, with an overall goal of risk and harm reduction.

#### **Policy Team Values:**

- Public confidence in what we do
- Achieving victim harm reduction and greater public safety through offender accountability and rehabilitation
- Treating all citizens fairly
- Respecting diversity and eliminating racial disparity
- Timely resolution to cases, with consistency in outcomes
- Competent justice system staff who operate with integrity
- Management of resources in an effective and sustainable manner
- Promoting transparency through the use of evidence based information to guide decision-making
- Being risk tolerant

**Policy Team Activities:** To ensure accomplishment of the policy team's mission, an action plan has been developed, defining the objectives and action steps the policy team will undertake. The action plan will be reviewed at each policy team meeting to ensure that tasks are completed as anticipated, and, updated as needed. The action plan is attached as Appendix 1.

**Meeting Frequency and Duration:** To accomplish its work, the policy team will meet on a regular schedule. The first meeting of the policy team will be April 16, 2015. Policy team

meetings will be held every month (excepting July, September and December) for a one year period of time. If accomplishment of the action plan requires more or less time, the policy team will readjust this schedule as necessary.

**Ground Rules and Operating Norms:** The following ground rules and operating norms have been established and team members have agreed to hold each other accountable for adherence to these rules and norms:

- Do not take anything personally
- Have an environment of honesty and trust
- Be willing to compromise
- Be respectful; everyone's comments should be heard
- Transparency about what we bring to the table and what our organizations are involved in
- Be willing to listen to new ideas
- Set aside parochialism
- Stay on task; be mindful of the goals
- Align the work of this group to the work of other groups and agencies
- Know your colleagues and their backgrounds; appreciate their comments
- Everyone participates
- Active engagement
- Come prepared
- Focus on the goal not the role
- Strive for consensus-based decision making; mutual agreement
- Have a meeting structure
- Attend the meetings regularly; only legislators are allowed to have designees because of their legislative and district responsibilities. (More information on this topic below)
- Be a positive advocate for EBDM; represent the group and work in a positive light
- Share what is happening with others outside of the group; discuss facts not opinions
- Set aside your ego, turf and title at the door
- Fulfill your responsibilities
- Start and end on time

**Decision Making Guidelines:** The policy team has agreed on the following guidelines for decision making:

Team members discussed making decisions based on consensus wherever possible. The team will use the "thumbs" method of voting to show support (thumbs up), hesitancy but willing to go along with the group (thumbs sideways) and disapproval (thumbs down). Only Legislators will be allowed designees with voting power.

**Team Membership:** Team members will be (have been) selected based upon their desire to serve, their representing an NIC identified stakeholder group, and their ability to advance the principles of EBDM. Appendix 2 contains detailed contact information.

designees will not be allowed except as noted above.

**Team Roles and Responsibilities:** The following roles have been established to support the effective work of the policy team.

- Chair. The role of Chair will be filled by David O'Leary. The Chair's role is to facilitate
  and oversee each policy team meeting and ensure that the team's mission and
  purpose is being fulfilled.
- Vice Chair. The role of Vice Chair will be filled by Kelli Thompson. The Vice Chair's
  role is to serve as the Chair in their absence. The Chair and Vice Chair will ensure
  regular attendance and will address other teams' issues that arise. Together they
  will also serve as the official spokespersons and media contacts for the State Team.
- State Team Coordinator. The role of State Team Coordinator will be filled by Matt Raymer. The State Team Coordinator's role is to organize meetings and activities

- and to manage all logistics for the state team.
- State EBDM Coordinator. The role of State EBDM Coordinator will be filled by Tommy Gubbin. The State EBDM Coordinator's role is to ensure alignment and collaboration between the state team and the six local teams, to include regular site visits and monthly conference calls.
- All team members have the following responsibilities:
  - Each team member will serve as a liaison to the constituency/agency/interest area they are representing, carrying key discussion points to these individuals and reporting feedback back to the team.
  - Each team member will serve as liaison to the community, communicating key decisions and operational changes, and reporting feedback to the team.
- In addition, the following unique responsibilities have been agreed upon:
  - Technical Assistance Provider. Mimi Carter will act as a meeting co-facilitator, provide technical assistance, and coach the policy team through the Phase V Initiative process so that objectives can be reached. She will also broker any additional technical assistance resources as needed, advocate for the team, and critique the team to assist in the achievement of all goals.
