APPROVAL OF 11/14/19 MEETING MINUTES

Motion was made by Sheriff David Mahoney to approve the 11/14/19 meeting minutes and seconded by Kelli Thompson. The motion was approved. Hon. Randy Koschnick noted a prior electronic version had a misspelling of his name, which was corrected.

SUBCOMMITTEE UPDATES

- Evidence- Based Decision Making Subcommittee – DA David O’Leary and Kelli Thompson
 - The Director of State Courts Office has hired a Pretrial Manager to manage the Pretrial Pilot Sites as they continue their implementation. Three counties are live with implementing the Public Safety Assessment (PSA), while others are still working on their contract agreements with the DOJ.
 - The next subcommittee meeting will be scheduled in February or March.
- Outreach/Education Subcommittee – Judge White and Tiana Glenna
 - The co-chairs and DOJ continue to discuss the history of the combined subcommittees (the Model Polices/Training Subcommittee and Outreach and Communication Subcommittee were merged at a previous CJCC meeting) and their previous membership. They continue to work towards identifying their next steps and creating a merged mission statement.
 - Moving forward the subcommittee will look to highlight the CJCC website, the EBDM TED talk, and the previously created position papers.
- Legislative Policy Subcommittee – Attorney General Josh Kaul
 - No current update on the creation/development of this subcommittee, but there is continued interested in the legislature and within the state agencies to create the subcommittee moving forward.

MARCH 2020 REPORT

- Criminal Justice Data Sharing Report – Connie Kostelac and Megan Jones
 - The co-chairs of the Data Sharing/OTIs Subcommittee reviewed a draft of the Data Sharing report.
 - Suggestions included highlighting needed statute challenges in terms of data sharing, recommending a standardized MOU for data sharing, discussing the continued issue of time and money for data sharing projects, recommending a central data sharing open record request process, and having a plan for the Outreach/Education Subcommittee to highlight data sharing efforts.
 - Any additional feedback will be provided to the subcommittee co-chairs prior to the next CJCC meeting.

- Treatment Alternatives and Diversion Program Report – Sheriff David Mahoney and Kelli Thompson
 - The co-chairs of the TAD Subcommittee reviewed a draft of the TAD Program Report.
 - Suggestions included adding an executive summary, including a cost benefit analysis, recommending a standard cost benefit analysis process for the state, and addressing how issues of education/workforce development will be addressed for program participants.
 - Any additional feedback will be provided to the subcommittee co-chairs prior to the next CJCC meeting.
 - Attorney General Kaul reviewed three areas that need to be kept in mind moving forward:
 - The continued interest by the legislature to expand TAD, including how there needs to be continued discussion about what kind of expansion is manageable, and what resources are needed.
 - The need to continually review types of treatment programs that are needed statewide. As Methamphetamine use continues to become a greater concern there needs to be treatment available for both Opioid and Meth users.
 - Lastly, there needs to be continued review of what stage of intervention will be most beneficial and will have the most impact.

NEXT STEPS AND FUTURE MEETINGS

- The subcommittees will incorporate the feedback from the meeting into the reports and provide a final copy of the reports at the next CJCC meeting.
- DOJ staff will continue to work with the subcommittee co-chairs as they move forward with their goals.
- The next CJCC meeting will be in February and will be scheduled soon. This meeting will focus on a final review and approval of the reports before submission.

PUBLIC COMMENT

There was a presentation on recent legislative development by Adam Plotkin. There are two packages of bills that may affect the work of the council moving forward. Katy Burke requested specific information about a bill related to OWI offenses, which Adam Plotkin will provide.

Chief Daniel Hardman made a motion to adjourn and Kelli Thompson seconded the motion. The motion was approved, and the meeting adjourned at 12 pm.
