Welcome

The meeting began at 12:15 p.m. AG Kaul welcomed new member EBDM Co-Chair Ray Woodruff and Assistance Deputy Secretary Kari Beier to the meeting. AG Kaul asked Ray Woodruff and Kari Beier to introduce themselves to the subcommittee. Quorum was present.

November 13, 2024, Meeting Minutes

Review March 12, 2025, CJCC Agenda DRAFT

Ryan Anderson began review of the March 12, 2025, CJCC Agenda DRAFT. Anderson reported that DOJ staff would provide an update on the Supreme Court Petition status at the CJCC meeting and at today's meeting.

Sabrina Gentile reported the Supreme Court held a public hearing on the State Bar Petition re: CLE credit for cultural competency and reduction of bias update to Supreme Court on January 15, 2025. The Supreme Court heard testimony in support and opposition. The Supreme Court held a public discussion after the hearing and voted to approve the

petition without any modifications. The Supreme Court discussed what month the petition would take effect. It was unclear when the petition would take effect. The court typically enacts "effective dates" of January 1 or July 1.

Anderson continued to review the CJCC Agenda. Anderson reported that each agency listed on the agenda will be contacted to see if they would like to provide a summary of the Governor's budget proposal for their agency. Anderson asked the subcommittee if anyone had any changes or suggestions.

AG Kaul directed DOJ staff to add a federal funding update to the agenda. Secretary Hoy suggested the Wisconsin Department of Administration (DOA) could also provide information for an update on federal funding. Secretary Hoy suggested working with the Assistant Deputy Secretary at DOA for information. AG Kaul directed DOJ Chief of Staff Ashley Viste to contact DOA for additional information to provide the federal funding update to the CJCC.

AG Kaul asked the subcommittee if anyone had any announcements. There were no announcements.
