National Standards for CJCCs – Review of WI DOJ Assessment and Action Plan

Lara Kenny reported the Department of Justice Staff will be interviewing candidates for the State Crisis Intervention Program Manager and Grants Specialist.

Kenny reported the CJCC Subcommittee Co-Chairs and the DOJ Staff are reviewing subcommittee membership and recruiting for additional members.

Kenny reported the DOJ Staff is reviewing the National Institute of Corrections (NIC) National Standards for Criminal Justice Coordinating Councils and applying the standards to the State CJCC. Kenny said the DOJ Staff is working on a

summary of how the State CJCC functions compare to the NIC Standards. Kenny hopes to present the summary to the CJCC Executive Subcommittee at the August 29, 2023, meeting.

Kenny reported that the DOJ Staff is in contact with agency partners and is putting together a sustainable training and outreach plan that has been suggested by local CJCCs. Kenny would like to include the training and outreach plan into a federal JAG grant application.

Kenny reported the CJCC website has been updated and encouraged the subcommittee to utilize for meetings and current CJCC and subcommittee information.

Executive Subcommittee Member Updates

Data Sharing/Outcomes, Trends and Indicators Co-Chair Connie Kostelac reported the co-chair position that was vacated by Megan Jones needs to be filled.

Kostelac reported the Justice Counts grant process can be linked to the work previously done with the Justice Reinvestment Initiative grant.
