#### Wisconsin Deflection Initiative (WDI)

#### Presented by Brad Kelly, DOJ – Bureau of Justice Programs

Brad Kelly reported the Wisconsin Deflection Initiative has expanded to 19 teams. WDI has a partnership with the Department of Health Services. Kelly reported on the use of opioid settlement funds to expand the program.

#### Justice Assistance Grant Update

#### Ryan Anderson, Criminal Justice Supervisor

Ryan Anderson provided an update on the Justice Assistance Grant (JAG).

- JAG will be cut by 16%. This takes funding levels back to 2020 levels.
- Contingency plan is in place to minimize effect of cuts.

## **Deflection Performance Measures Guide**

# Presented by Christine Shulz, DOJ – Bureau of Justice Information and Analysis

Christine Shulz reported on the Deflection Performance Measurements Guide. The Guide includes:

- Assists in understanding how programs work and identify areas of approvement.
- Assists with developing and measuring WDI programs.
- Provides roadmap for programs to measure program outcomes and performance.
- Explains program Designs and Different Outcomes Measured
  - Targeted Outreach
  - Participant Recovery & Engagement Program

The Performance Measures Guide was developed by the Performance Measure work group consisting of deflection practitioners, evaluators, law enforcement, district attorney's, department of health.

The Performance Measures Guide will be posted on the CJCC website as a guide for data collection for all WDI programs.

Deflection programs can be implemented in a variety of ways and the hope is the performance measurement guide can still be utilized by current and future teams.
