AGENDA TOPICS

Welcome and Opening Comments

The meeting was called to order at 12:02 p.m. Kelli Thompson gave the welcome and opening comments.

Noting the addition of Katy Burke to the attendees, a motion to approve the 2/25/2021 minutes was made by Mark Abeles-Allison and seconded by Melvin Juette. The minutes were approved unanimously.

Updates

- WATCP Equity & Inclusion Committee – Reneé Lushaj & Ashley Billig
 - Lushaj discussed the 9 pilot sites and report created through the committee.
 - Billig reviewed data reports that were created by BJIA using data from CORE and CCAP surrounding RED data. The report is broken into three parts: Part 1: Who is Being Referred; Part 2: Who is Eligible; Part 3: Who is Admitted and Current Status.
 - Each of the pilot sites will receive their own data report. The aggregate report will be provided to subcommittee members.
 - J.C. Moore expressed appreciation for the work Lushaj and Billig have done in support of the upcoming WATCP conference, which will have a strong emphasis on equity and inclusion.
 - Jessica Skemp expressed concern with only using drug charges from CCAP and potentially underrepresentation of individuals potentially eligible for the program.
 - Tamara Oman suggested potentially having community listening sessions with underrepresented individuals.
 - Lushaj underscored the need for counties to look at their own county level data (jail population data), as DOJ does not have access to this data.
 - Judge Levine suggested utilizing data being collected during the pretrial screening process.

- WATCP Legislative Affairs Committee – Adam Plotkin
 - WATCP plans to provide an informational legislative briefing on Friday, May 7th.

- Representative Goyke and Representative Zimmerman will be extending invitations to their colleagues.
- TAD Webinar Presentation to Legislators - DOJ Staff
 - Lushaj provided a recap of the TAD webinar presentation. The presentation seemed well received with around 20 legislators attending. There were questions around the match requirements. Emphasis was placed on increasing staff support for the TAD program. Lushaj will send out the link to the recorded presentation.
 - Oman brought up the importance of considering funding for mental health courts. Burke reported there are currently five mental health courts in the state. Lushaj reported that the requirement for a substance use diagnosis has been removed from the TAD statute to allow for broader funding opportunities.

Diversion Standards – Update, Review & Approval

- Equity & Inclusion Language
 - Lushaj reviewed the changes made to the Diversion Standards document and the inclusion of more specific equity and inclusion verbiage. Committee members made suggestions for further changes and using more person-centered language. Lushaj will send out the document to members for further feedback which should be submitted to Lushaj by 4/30.
- Drug Testing Appendix
 - Lushaj reviewed the discussion of the drug testing workgroup. Discussion was held regarding the legal ability of a diversion program to drug test an individual and does that change dependent on whether the program is pre-charge or post-charge.
 - Lushaj discussed the placement of the drug testing information in the Diversion Standards document. Members agreed to add the information as an appendix.

- Becci Main discussed a new PSA campaign on the use of naloxone for individuals being released from jail. DHS is looking for individuals who have lived experience and who have used naloxone. Also looking for a law enforcement representative and a treatment provider to be involved. Stipends are available. Contact Main, Lushaj, or Burke for more information.
